## Emissions reduction targets

We have engaged Carbon Neutral Britain to measure and calculate our carbon footprint for 2021/2022, with the purpose of offsetting our total organisation emissions to become Carbon Neutral.

Carbon Neutral Status has been awarded to the organisation for a period of 12 months from January 2023.

## Carbon reduction projects

We are a services business, during the pandemic we moved to a working from home model which will continue in future years. This has reduced the amount of carbon we produced by not owning an office or company vehicle. This has enabled us to be paperless and move everything online.

In the future, we hope to implement further measures such as:

- Supporting the Tree Council to plant at least 200 trees for the next 2 years.
- Continue to use public transport to commute if needed.
- Through our Carbon Neutral Britain Woodland Fund™, JGP Resourcing Ltd has offset its total carbon emissions through internationally certified carbon offsetting projects.

## Declaration and sign off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
